Share Fair a Success for ICA

The Sharing Approaches That Work Conference, or Share Fair, was held on September 15, 2012, and was a resounding success.

The event, organized by the Institute of Cultural Affairs, drew more than 400 people and 140 community initiatives to Uptown's Truman College. Each organization present showed their current activities, future plans and connected with others during the day-long conference. The event was part of the Accelerating Green Initiatives in Chicago's 77 Community Areas (Accelerate 77) project and one of the celebrations of the ICA's 50th Anniversary. This dynamic concept can be replicated across the country.

Lisa Parker, a Consumer Affairs reporter for Chicago's NBC television station, opened the event and welcomed the participants. Terry Bergdall, President and CEO of the ICA, spoke along with Chicago Aldermen James Cappleman (46rd Ward) and Deborah Graham (29th Ward).

Karen Weigert, Chief Sustainability Officer for the City of Chicago, gave the keynote address. She talked about the efforts of the city and its residents in improving the environment and creating sustainable systems. She added that it was thanks to those efforts that, in April, Chicago had been rated as one of the most sustainable large communities in the country.

Connection Seminars were also held throughout the day, covering topics including sustainable transportation, green economics, community organizing and innovation. The seminars were facilitated by supportive organizations such as Openlands, The Field Museum, the Center for Neighborhood Technology, Active Transportation Alliance and Energy Impact.

Accelerate 77 is a three-year program to increase the role and positive impact of local communities in realizing objectives of the Chicago Climate Action Plan. Its underlying strategy is to identify current sustainability initiatives in all of Chicago's 77 community areas; connect them with one another to inspire new ideas, practices, self-consciousness and motivation through peer interchange; and engage residents in systematic learning, planning, and collective action. ICA anticipates that the project will thereby accelerate environmental sustainability in a bottom-up fashion driven by practical action, expanded imagination, and greater organizational capacities among local groups.

The week also had the unveiling of the artwork commissioned for the 50th Anniversary. It was unveiled at 4750 N. Sheridan Rd. in Chicago on September 13, 2012.

"Ocean of Devotion," a creation of Chicago artist Gina Alicea, was also part of an event for Business Partners, the Chamber for Uptown. The ten-foot by five-foot piece contains more than 1,000 strips of cloth with handwritten messages from ICA events and people across the world. Gina sewed the strips like a quilt and veiled the piece with a semi-transparent blue cloth.

"There was such a wonderful energy in reading each of the pieces of cloth, reading them, ironing them – to feel what I think they were feeling," Gina told the local newspaper *Inside-Booster* that reported on the unveiling.

"Ocean of Devotion" is in the lounge of the ICA building's sixth floor offices. A video of the presentation of the artwork is available on the ICA website.


