INTRODUCTION

PSU TASK

The task of the Social Methods Problem Solving Unit was to collect, disseminate and organize the wisdom and methodologies associated with the researching of the New Social Vehicle. Summer '71 enabled us to give theoretical and proceedural form to our sociological intuitions. This release of creativity has made the amount of methodological tools available to us immense, thus the need for a systematizing of these tools is the basis of our task.

REVOLUTIONARY PHILOSOPHY We utilized our time collecting and brainstorming the wisdom available in our arena. After our gestalt was complete, we divided the content into two areas, the philosophy and the method. The categories under the philosophy are Revolutionary Forces, Trend Analysis and Valuational Screen. We then arriculated in prose what each of these three consisted of, using both the objective reality in each, as articulated in Document E and the key insight about the social dynamic of humaness disclosed by the researching of that area.

SOCIAL METHOD

The four methods are Social Triangles, Valuational Screen, Preproposal Claim, and Contradiction/Proposal. We have broken down these four into the three processes and have broken down each process into three steps. These methods, processes and steps each have elaborating sentences on what they consist of and a stepment of the retional and existential objectives of each.

FIRST ATTEMPT

The significance of our work is that it is the first attempt to articulate how one might practically operate within the context of the trans-establishment, which is a demand laid upon the Globa! Spirit Movement out of Summer '71.

Social change is the process of the New developing dominance over the Old. This process depends upon the interaction among the transestablishment, the disestablishment, and the proestablishment. The transestablishment holds the tension between the proestablishment and the disestablishment, both of which comprise the establishment, in order to enable the emergence of the New Social Vehicle.

SOCIAL CHANGE

The proestablishment is that part of society which embodies and seeks to maintain both the healthy and malfunctioning manifestations in the social process. It is that dynamic which looks to the past for guidance, relies on tradition and precedents, and is dedicated to the maintenance of familiar standards. The ungift of the proestablishment is its tendency toward a static world view and a past oriented life style which blindly denies significant change.

DISESTABLISHMENT DYNAMIC

PROESTABLISHMENT

DYNAMIC

The disestablishment empodies the negative and positive aspects of emerging trends and therefore opposes the traditional context of the proestablishment. The ungift of the disestablishment lies in the negative aspect of the trend which blindly demands the total destruction of the proestablishment's manifestation of traditional social values, rather than standing in opposition only to the dysfunctioning aspects.

TRANS-ESTABLISHMENT DYNAMIC

The transestablishment is that dynamic which finally brings into being the New by maintaining the tension between the dynamic which grasps the significance of the past, and that which calls the past into question. The transestablishment authentically creates the new through the formulation of an ideological stance of what it is to be human, and therefore, what is required in the social existence of man. That stance enables the transestablishment to detach itself from the proestablishment and disestablishment, and therefore, comprehensively create the future. By disclosing the significant trends of the times, it enables the old to be pushed into the new. The primary danger facing the transestablishment at every moment is the failure to self-consciously embody its stance in the midst of practical planning relative to the invention of the future and therefore, collapsing into the stance of the dis- or pro-establishment.

TRANS-ESTABLISHMENT POSTURE The creation of history is finally found in the dynamical relationships of tension between that part of society whose major intent is to preserve the past and that part of society which is primarily concerned with breaking loose from the past. This tension is finally held creatively in the transestablishment which forges a stance beyond both other dynamics. From there, it is able to perceive and take responsibility for the trends of history which are moving against the contradictions of the old and forging the new.

HISTORICAL **DYNAMIC**

History is continual change. Whenever contradictions develop in the old society, the new arises in response to the development of contradiction in the old. There is always emerging out of the old society trends and malfunctions which produce these contradictions. TREND

EMERGENCE

MALFUNCTIONS

Historic pre-trends occur out of the necessity to respond sensitively to questionable relationships in the Social dynamic. These tangents indicate malfunctions in the social dynamic as well as point future directions for the society. By anming these tangents they become trends--self conscious forces pushing for change in the present society. these trends coagulate and become significant in power as well as a wide-spread manifestation withing the society. a master trend is revealed. This master trend is the in clusive impulse of all the pre-trends toward the new. master trend has many components which could be described as sub-trends. The sub-trends withing themselves have a relatively limited amount of significance, but together they indicate a major shift in the direction of history. Trends are simply new directions which stand over against malfunctions. In this sense, they can be as demonic as the malfunctions which they have arisen to deal with, in that they occasion active, rather than passive human agony. Every trend has a positive aspect which as a movement toward the future is blocked and a negative aspect, which as a perversion impedes the creation of the new.

Every trend within the disestablishment reveals pervasive malfunction within the proestablishment. Malfunction occurs in the fabric of society when there is a collapse or under-functioning in any of the dynamics that hold soceity in being, or when one arena dominates or tyrannizes another. Dependable evidence of societal malfunctioning is the innocent suffering of individuals and groups of people. Naming the malfunction catalyzes the identification of pre-trends in wed and a description of the inherent contradiction. Naming the malfunctions catalyzes the identification of pre-trends and is the first step in the description of the contradiction.

TREND REDIRECTION

Redirection is a process of altering a trend, freeing its positive or humanizing aspect from the situation which blocks it, and altering its perverted aspect to contribute usefully to the onward flow of developing humanness. The counterblock to the positive aspect of the trend enables the trend to employ all of its potential weight in relieving human suffering by shifting the circumstances. The corrective to the perverted aspect is the means by which this perverted aspect is rendered futuric, comprehensive, intentional and archaic enough to contribute to human society. The counter block gives effectiveness to the trend, while the corrective demands that the trend enrich the building of humanness. The redirection function of a proposal focuses the trend effectively toward the emergence of a new human response to innocent suffering. The redirection function of a proposal allows the social dynamics to employ the trends in the midst of the social process.

FUNCTION

The existence of a malfunction necessitates inclusive recommendations which will reformulate it, leading to the new. The restoration of a collapse is a strategic system of proposals REFORMULATIONwhich emphasize the rational pole of the social processes triangle, proposals leading to a rebalancing are crucial. processes are essential and conjunctive, for the tyranny evolves into collapse and the collapse results in tyranny.

CORPORATE ELECTION

History has always operated out of the dynamics of trends and malfunctions. The new is always created out of the old and will replace it. These dynamics themselves imply that some group will make a corporate decision about what is THE trend, what is THE contradiction, and will take action to enable the redirection and reformulation of the whole fabric of society. This corporate decision to name the trend is finally what validates the trend. The trend today is the cultural revolution, which seeks to rebalance society and remove the tyranny of the economic. The demand on those who decide to stand as the transestablishment is to clearly discern the trends, and malfunctions and create the comprehensive models which will redirect and reformulate the new society.

SCREEN FUNCTION

In order for a revolutionary to perceive the radically new, he must force his imagination beyond the limits of socially programmed images. A valuational screen is an overlay comprised of the basic presuppostions through which a social dynamic is examined for validity. Such a screen both interprets and informs present processes and thus shapes future designs relative to the basic presuppostions. The insight of valuation screen is that it is possible in our time to self-consciously and rationally create such a screen and force yourself to perceive reality through that screen.

MASS INTUITION

Mass intuition is the gathering of the sociological wisdom that is collected from any numan endeavor and giving it tangible form. This requires a tapping of man's consciousness of his solitary development, his consciousness of society's development, and therefore his consciousness of the movement of life's mystery itself. Mass intuition is out to research the images that formed this consciousness and use these images to point to the signs of the times.

SOCIAL PROCESS TRIANGLES

The social process triangles are a rational articulation that is inclusive and faithful to man's social experience and makes it possible for man to view his total societal context and make responsible decisions in the midst of the collapse of societal structure. This abstract model is based upon the presupposition that social processes are tripolar and inclusively interrelated and apply to the life realities to every social group and society. This screen states the common consciousness of the movement relative to the economic, political, and cultural dimensions of society and thus as a tool for social analysis it reveals that society's participation in history through a particular set of glasses.

The theoretical screen is intensely normative and is composed of three parts: the social process triangles, the interior and exterior dynamical relationships of the social process, and the cultural bias as particularly viewed in the rational poles of the triangles.

DYNAMICAL RELATIONSHIPS

The insight of the relatedness of the social dynamics triangles is that it is possible to have a contentless overlay which allows every local man to gain clairty on all dimenstions of the social process in which he participates. These dynamical relationships articulate the depth relatedness of all social processes, revealing their interdependency as well as the danger of the collapse of any dimension. Each pole of the triangulation creates, judges, and sustains every other pole, as well as itself, releasing creative response to the demands of the historical process. By forcing the grounding of these relationships in actual life experiences, the triangles enable the focusing of reflection and decision relative to the shape of human relatedness. Through this screen local man is able to perceive functions, tensions, and disrelations in the social process which allows him to participate practically in the creation of his own destiny.

CULTURAL BIAS

The third theoretical value screen on which a proposal is based is cultural bias. The stance of the movement relative to the cultural is that there is a depth break through in consciousness in our time and that out of that breakthrough has come the cultural revolution. This revolution resulted from the impact of Post-Einsteinian science on the Newtonian world-view, radical urbanization, and the secularizing of religious_symbols. It brings new possibilities through which man can bring self-consciousness to the creation of the future through social renewal. The fact that today's revolution is cultural means that the social processes dynamic is bent in that direction. The tri-fold dynamic of the economic, the political, and the cultural becomes five-fold: two extra beats are addded to the cultural. Intensification in a rational manner is given to the cultural.

I DEOLOGICAL/ ONTOLOGICAL POSTURE The final valuational screen is the ideological stance of the movement. This is the most intensely normative of the screens. It is the sociological articulation of our ontological posture. "All the Earth Belongs to All the People" is the social articulation of the Christ word for our time. This ideological stance is the rational screen through which the radically human is disclosed in society. This disclosure in turn reveals authentic social contradiction. Looking through this screen, one perceives self-consciously his situation.

WISDOM GESTALT

The valuational screen is an inclusive practical gestalt of the Movement's social wisdom which allows masses of people to move as a common historical thrust. The valuational screen reorganizes the images making up one's memory in order that he be released to appropriate the wisdom gained in his own experience. By overlaying a valuational screen, any man can practically operate out of the stance of the Word and be free to appropriate all the wisdom of his memory. This allows the wisdom of many individuals to be tapped and channeled into a common mind. The valuation screen allows the Movement to methodologically assume the posture of the Transestablishment. This is realized by releasing the Movement to perceive rationally the ontological stance and basic presuppositions out of which it operates. The valuational screen is the step by step process toward embodying the Christ Word self-consciously in a sociological context.
