This indicates that the underlying challenge is NO FULL TIME LEADERSHIP TO TRACE ALL POSSIBLE SOURCES OF HELP AND DIRECT LONG TERM PROJECTS.

We the citizens of Lena, in order to DISCOVER THE ROLE OUR SMALL TOWN CAN PLAN propose to HOLD REGULAR "TOWN MEETINGS" (ONCE A MONTH OR ONCE EVERY TWO MONTHS) through
